DEADLINES

You'll be considered for all financial aid scholarships for which you are eligible only after we have received all of your completed admissions and financial aid materials and if you've been accepted into the program. We must receive complete applications **no later than April 1**. We are sorry but we cannot accept any financial-aid applications after the deadline. Financial-aid decisions will be made no later than April 30.

Because we award aid until our funds are depleted, and funds may be depleted before the application deadline, it is to your advantage to apply as early as possible. We cannot consider applications with incomplete or unexplained items or guarantee that all eligible applicants will receive aid, even if they applied well before the financial aid application deadline.
